

## **Oodle Noodle "Noodzmas" Contest Terms and Conditions**

### 1. Contest Period

The Oodle Noodle "Noodzmas" Contest (the "Contest") will run from November 4, 2024, to December 23, 2024, at participating Oodle Noodle locations.

### 2. Eligibility

To be eligible to enter the Contest, you must:

- Be at least 18 years of age at the time of entry.
- Employees, franchisees, and immediate family members (parents, siblings, spouses, and children) of employees or franchisees of Oodle Noodle are not eligible to enter the Contest.

### 3. How to Enter

Contestants must visit participating Oodle Noodle locations during the contest period. An entry is free without purchase. One free entry per day. Customers can enter again, once per day, with any purchase.

### 4. Prize

One (1) Grand Prize will be awarded, consisting of a voucher for fifty-two (52) free signature boxes within one (1) year. The Grand Prize includes:

- Fifty-two (52) free signature boxes, redeemable within one (1) year of awarding, and can be used a maximum of one (1) time per day.
- One (1) \$25 gift card or voucher for one of Skip the Dishes or Uber Eats platforms, determined by Oodle Noodle at the time of awarding the prize.
- Approximate value of the Grand Prize is \$517.40.

### Important Conditions:

- The prize is non-transferable and cannot be exchanged for cash or any other offer.
- If the winner is unable to claim their prize for any reason the prize will be forfeited, and no alternate prize will be awarded.
