

Oodle Noodle "Nation Vacation Vegas 2026 Contest" Terms and Conditions

1. Contest Period

The Oodle Noodle "Nation Vacation Vegas 2026 Contest" (the "Contest") will run from February 9, 2026, to March 1, 2026, at participating Oodle Noodle locations.

2. Eligibility

To be eligible to enter the Contest, you must:

- Be a legal resident of Canada.
- Be at least 21 years of age at the time of entry.
- Hold a valid passport.
- Employees, franchisees, and immediate family members (parents, siblings, spouses, and children) of employees or franchisees of Oodle Noodle Franchise Corporation are not eligible to enter the Contest.

3. How to Enter

Contestants must download the Oodle Noodle app on the Apple Store or Google Play Store during the contest period and register with a phone number and/or email. All customers that have registered will be eligible to win the Grand Prize.

4. Prize

One (1) Grand Prize will be awarded, consisting of a trip for two (2) to Las Vegas, Nevada, from March 24 – 27, 2026. The Grand Prize includes:

- Round-trip airfare from Edmonton International Airport (YEG) to Harry Reid International Airport (LAS).
- Bus transfer to and from the LAS airport and Las Vegas hotel.
- Accommodation for two (3) nights in Las Vegas, Nevada, for two (2) people in a shared room.
- Exclusive ticketed watch party with the nation crew on March 24, 2026, to watch Edmonton Oilers vs. Utah Mammoth.
- Two (2) tickets to the Edmonton Oilers at the Las Vegas Golden Knights on March 26, 2026, at 7:30pm MST.
- Hotel security deposit is the responsibility of the Winner. Any, and all outstanding hotel charges, including damages incurred, are the responsibility of traveler and due upon check-out.

Important Conditions:

- The winner is responsible for their transportation to and from Edmonton International Airport.
- The prize is non-transferable and cannot be exchanged for cash or any other offer.
- The winner must hold a valid passport for travel if required.
- If the winner is unable to claim their prize for any reason (including lack of a valid passport), the prize will be forfeited, and no alternate prize will be awarded.

5. Winner Selection

One (1) winner will be selected by random draw from all eligible entries. The draw will take place on or about March 2, 2026. The winner will be notified via phone call and/or email address depending on registered data submitted by the contestant.

The winner will have 24 hours from the time of the notification to claim the prize. If the prize is not claimed within this period, an alternate winner will be selected by random draw.

6. Consent and Publicity Release

- By entering the Contest, participants agree to: Abide by these Terms and Conditions.
- Allow Oodle Noodle Franchise Corporation ("ONFC") to use their name, likeness, image, and personal information (such as first name and last initial, city of residence) for promotional, marketing, or publicity purposes in connection with the Contest without additional compensation or notification.
- The winner may also be required to participate in marketing, publicity, or promotional activities as part of accepting the prize.

7. General Conditions

Acknowledgment of Risk: The Winner, acknowledges that participation in the Nation Vacation (hereafter referred to as "the Event") hosted by The Nation Network ("TNN") involves inherent risks, including but not limited to travel risks, accidents, personal injury, and loss or damage to personal property. The Winner, understands that these risks can arise from various sources, including transportation, accommodations, activities, and interactions with other participants.

Release and Waiver: In consideration of being allowed to participate in the Event, the Winner, hereby release, waive, discharge, and covenant not to sue ONFC and/or TNN, its officers, employees, agents, and affiliates (collectively referred to as "the Released Parties") from any, and all claims, liabilities, demands, or causes of action that they may have now or in the future for any injuries, damages, losses, or expenses arising out of or in any way connected with participation in the Event, including but not limited to claims arising from the negligence of the Released Parties.

Assumption of Risk: The Winner, understands that participation in the Event is entirely voluntary and that they are solely responsible for their own safety and well-being and further acknowledge that they have been advised to obtain personal insurance coverage for participation in the Event.

Medical Authorization: In the event of an emergency, the Winner, authorizes TNN and its representatives to obtain medical treatment for the Winner, if necessary. The Winner agrees to be responsible for any medical expenses incurred as a result of participation in the Event.

Code of Conduct: The Winner, agrees to conduct themselves in a respectful and responsible manner throughout the Event, and understand that TNN reserves the right to

terminate participation in the Event if the Winner(s), behavior is deemed inappropriate or harmful to themselves or others.

Indemnification: The Winner agrees to indemnify and hold harmless the Released Parties from any, and all claims, actions, suits, procedures, costs, expenses, damages, and liabilities, including attorney's fees, brought as a result of their participation in the Event and to reimburse them for any such expenses incurred.

The Contest is subject to all applicable federal, provincial, and local laws and regulations. Void where prohibited by law.

8. Privacy

Personal information collected from participants will be used solely for the purposes of administering the Contest and awarding the prize. Oodle Noodle will not share personal information with third parties, except as necessary for the fulfillment of the prize.
