

OODLE NOODLE “\$1,000 MONTHLY APP GIVEAWAY” CONTEST TERMS AND CONDITIONS

1. CONTEST PERIOD

The Oodle Noodle “\$1,000 Monthly App Giveaway” Contest (the “Contest”) begins on the date it is first announced by Oodle Noodle Franchise Corporation (“ONFC”) and will continue monthly until terminated by ONFC.

ONFC reserves the right to modify, suspend, or terminate the Contest at any time without prior notice.

2. ELIGIBILITY

To be eligible to enter the Contest, participants must:

- Be at least **18 years of age** at the time of entry.
- Be a **registered member of the Oodle Noodle loyalty program through the official Oodle Noodle mobile app.**

Employees, franchisees, and immediate family members (parents, siblings, spouses, and children) of employees or franchisees of Oodle Noodle Franchise Corporation are **not eligible** to enter the Contest.

3. HOW TO ENTER

Participants will automatically receive **one (1) entry** into the monthly Contest draw by:

- Downloading the Oodle Noodle mobile app, and
- Registering for the Oodle Noodle loyalty program.

Existing loyalty program members who are already registered in the Oodle Noodle mobile app will **automatically be entered** into the monthly Contest draw.

No purchase is necessary to enter or win.

Each eligible loyalty member will receive **one (1) entry per monthly draw period**, unless otherwise specified by Oodle Noodle Franchise Corporation.

4. PRIZE

Each month, **one (1) winner** will be selected to receive:

One Thousand Dollars (\$1,000 CAD) in loyalty points added to the winner’s Oodle Noodle loyalty account, redeemable at participating Oodle Noodle locations, on www.oodlenoodle.ca, or through the Oodle Noodle mobile app.

Prize Conditions:

- The prize will be awarded in the form determined by Oodle Noodle Franchise Corporation.
- The prize is **non-transferable and cannot be exchanged for cash or any other offer.**
- If the winner cannot be contacted or fails to respond within **seven (7) days**, the prize may be forfeited, and another winner may be selected.

5. WINNER SELECTION

One (1) winner will be selected **by random draw each month** from all eligible entries received during the monthly draw period.

The draw will be conducted by Oodle Noodle Franchise Corporation.

The selected winner will be notified by:

- **Email from admin@oodlenoodle.ca**, or
- **Telephone call** using the contact information associated with their loyalty program account.

Participants are responsible for ensuring their contact information in the Oodle Noodle loyalty program is accurate and up to date.

Odds of winning depend on the number of eligible entries received during the monthly draw period.

6. SKILL-TESTING QUESTION

To be declared a winner, the selected entrant may be required to correctly answer a **time-limited mathematical skill-testing question**, administered by Oodle Noodle Franchise Corporation, without assistance of any kind, whether mechanical or otherwise.

Failure to correctly answer the skill-testing question may result in **disqualification**, and an alternate winner may be selected.

7. CONSENT AND PUBLICITY RELEASE

By entering the Contest, participants agree to:

- Abide by these Terms and Conditions.
- The collection, use, and storage of their personal information (name, email address, and phone number) by Oodle Noodle Franchise Corporation for the purposes of administering the Contest and contacting winners.
- Allow Oodle Noodle Franchise Corporation to use the winner's name, likeness, image, and city of residence for promotional, marketing, or publicity purposes related to the Contest without additional compensation or notification.

Participants may opt out of receiving promotional communications at any time by following the unsubscribe instructions included in communications from Oodle Noodle.

8. FRAUD AND ABUSE PREVENTION

Oodle Noodle Franchise Corporation reserves the right to **disqualify any entrant** who is found to be:

- Using multiple accounts, identities, or registrations to gain additional entries.
- Attempting to manipulate, hack, or otherwise interfere with the Contest, the loyalty program, or the Oodle Noodle mobile app.
- Violating the Contest Terms and Conditions.

Any attempt to deliberately damage the Contest, the mobile app, or associated systems may be a violation of criminal and civil laws, and Oodle Noodle Franchise Corporation reserves the right to seek damages and pursue all available legal remedies.

ONFC may remove entries or suspend loyalty accounts suspected of fraudulent activity.

9. TECHNOLOGY AND SYSTEM LIMITATIONS

Oodle Noodle Franchise Corporation is not responsible for:

- Technical failures of the Oodle Noodle mobile app or loyalty program.
- Incomplete, delayed, or failed registrations or entries due to network issues, software failures, or device incompatibility.
- Lost, late, misdirected, or corrupted data transmissions.

If the Contest cannot be conducted as planned due to technical issues, tampering, fraud, or other causes beyond the reasonable control of ONFC, Oodle Noodle Franchise Corporation reserves the right to modify, suspend, or terminate the Contest.

10. GENERAL CONDITIONS

By participating in the Contest, entrants agree to release and hold harmless Oodle Noodle Franchise Corporation, its franchisees, employees, and affiliates from any liability arising from participation in the Contest or acceptance and use of the prize.

The Contest is subject to all applicable federal, provincial, and local laws and regulations.
